<p><b>OPPOSES COMPREHENSIVE SEX EDUCATION IN PUBLIC SCHOOLS</b></p> <p>Public schools should not implement expansive and comprehensive sex education curriculum that includes LGBTQ+ sexual experiences, practices, and identities.</p>	—	—
<p><b>SUPPORTS CONSTITUTIONAL AMENDMENT FOR PARENTAL RIGHTS</b></p> <p>The Delaware Constitution should be amended to protect the right of parents to the control, custody, and care of their children from government interference, which requires the government to prove that it has a strong, compelling reason to restrict that right, such as in cases of abuse and neglect.
